Grayson County Board of Supervisors
Regular Meeting
July 13, 2017

Members attending were: Brenda R. Sutherland, Kenneth R. Belton, John S. Fant, Glen E. Rosenbaum and Michael S. Hash.

IN RE: OPENING BUSINESS

Supervisor Sutherland welcomed Mr. Bill Shepley as the new County Administrator. Supervisor Sutherland requested the Board table the last agenda item under new business (Establish Capital Improvement Fund for Grayson County School); motion made by Supervisor Rosenbaum. Supervisor Fant made the motion to approve the amended agenda and consent agenda; duly seconded by Supervisor Rosenbaum. Motion carried 5-0.

IN RE: PRESENTATIONS OR REQUESTS

Mike Guy, Director of District III Governmental Cooperative, thanked the Board for the opportunity to give an update on their agency. District III Governmental Cooperative Extension has a budget of \$5.3 million with funding from various sources. Mr. Guy noted that 5500 senior citizens were served over last year. The Farm Fresh Program is going well and coupons are given out for fresh food at the Farmers Market which

includes 640 Grayson County citizens. Mr. Guy reviewed the services provided and how many citizens were served through each service. In 2016, Senior Day was held for the first time and another one is planned for September 2017. Mr. David Richardson then spoke reviewing the history of public transportation service, noting that it's not just for senior citizens. Currently they operate 16 hours of service per week in Grayson County and that number was set by a previous Board of Supervisors back in the 1990's and can be amended.

Erin Farmer, Grayson County 4-H, addressed the Board and reported that 4-H camp will be held July 24-28 with the theme being "Into the Wild" with swimming, survival, archery, rifling classes, etc. Grayson County has 69 campers signed up with student leader selected and held to higher expectations. Several scholarships were donated and fundraising efforts took place throughout the year. A full scholarship is valued at \$185.00. Mrs. Farmer then introduced Mr. Daniel Boyer, who is the new hire for the Matthew Farm/Grayson County 4-H. Mr. Boyer is a local young man who comes from the Spring Valley community. Already on the agenda for Mr. Boyer is a meeting with Grayson LandCare, Grayson County School Board meeting, Agri-Business Tour and Heritage Day. Mr. Boyer noted that his goals are the livestock club, farm plan – which would be student run, increase visitation and financial stability.

Jonathan Luper, Director of Grayson County Public Works, gave the following year-end update:

- FY-17 Large Item Pickup Expenditures: \$22,332.85 which is off-set by the Liter Grant but funding hasn't been received yet.
- Cost is down and the County is cleaner – The New River Wildlife Club is also seeing less trash during their annual clean-up.
- FY-17 Recycling totaled \$99,751.00 in rebates which is up 16% from FY-16.
- Currently look to pilot an agricultural-plastic recycling program, starting in the fall.
- Household Hazardous Material program: would recommend holding semi-annually in the County to reduce the amount of hazardous household waste in the County. It was astounding at the amount and type of material that came in that day.

Kelly Wilmore, Superintendent of Grayson County Public Schools, addressed the Board regarding a CIP request for school buses. The school bus lease payment would be \$88,922.30 which would be the first of five (5) buses. Mr. Wilmore noted the life cycle of a bus is about ten (10) years but that also depends on the route. This money was previously approved in the budget. Supervisor Fant made the motion to approve; duly seconded by Supervisor Rosenbaum. Motion carried 5-0. Mr. Wilmore also noted that he would be at the next board meeting to talk about literary funds.

IN RE: OLD BUSINESS

- UPDATE ON MAIN STREET INTERSECTION (SMART SCALE) AND PLEASANT GROVE ROAD – JEFF RUSSELL, VDOT

Mr. Russell gave an update that mowing crews are getting caught up after the rain and paving crews will be moving in over the next few weeks. Mr. Russell gave the history of the Smart Scale Intersection and that the purpose to improve the turning radius at Rt. 58 and Rt. 21; the original plan impacted the historic Courthouse so it was redesigned to leave the historic Courthouse property as is. Mr. Russell went on to explain that VDOT has recently met with County and Town of Independence officials to further discuss options with the most benefit. The estimated start date is 2020. Mr. Russell then spoke regarding the Pleasant Grove Road concerns. Unfortunately, Pleasant Grove Road does not meet Rural Rustic Guidelines and would have to be considered as a construction project. The estimated cost to pave the target area is approximately \$2.5 – 3.0 million. The money could come from the six (6) year plan but other improvements would have to stop to allow the money to build up.

IN RE: BOARD APPOINTMENTS

Building Inspection Board of Appeals – 4yr term: Doug Williams resigned; new appointee will fill the remainder of Mr. Williams term which will end 12/31/17. Mr. James Moss, Building Official, requested an engineer fill this spot. Mr. Moss will send the requirements to the Board. No action was taken on this appointment.

Economic Development Authority – 4yr term: Mr. Robert “Bobby” Williams does not wish to be reappointed – his term expires 08/08/17. Supervisor Fant made the motion to approve Esko Lehtinen; duly seconded by Supervisor Belton. Motion carried 5-0.

New River/Mt. Rogers Workforce Development Board: David Sexton is unable to continue to represent Grayson County due to business duties. No action was taken on this appointment.

IN RE: SURPLUS – GRAYSON COUNTY SHERIFF’S OFFICE

Supervisor Hash made the motion to approve the surplus of a 1998 Ford F-150 4-wd with approximately 130,000 miles; duly seconded by Supervisor Fant. Motion carried 5-0.

IN RE: RESOLUTION – GRAYSON COUNTY EMERGENCY OPERATIONS PLAN (EOP)

James S. Moss, Emergency Services Coordinator, gave an overview of the process and explained that all plan non-specific information has been placed into appendices to

allow for real time updates and not require board action on every change in personnel or equipment. The EOP must be updated every four (4) years. Mr. Mitchell L. Smith read the Resolution (listed below). Supervisor Hash made the motion to approve; duly seconded by Supervisor Rosenbaum. Roll call vote as follows: Supervisor Hash – aye; Supervisor Rosenbaum – aye; Supervisor Belton – aye; Supervisor Fant - aye; Supervisor Sutherland – aye. Motion carried 5-0.
